



CALIFORNIA PROPOSITION 65 & CHAMPLAIN CABLE CORPORATION'S PRODUCT DISCLOSURE

Some of our products may contain one or multiple of the following chemicals listed under Proposition 65 (a.k.a. "Prop 65"), known to the State of California to cause cancer:

- Acetaldehyde (CAS No 75-07-0)
- Antimony Trioxide (1309-64-4)
- Benzene (CAS No 71-43-2)
- Bisphenol S (BPS) (CAS No 80-05-7)
- Carbon Black (CAS No 1333-86-4)
- Di-"isononyl" phthalate (DINP) – (CAS No 28553-12-0)
- Ethyl Benzene (CAS No 100-41-4)
- Ethylene Glycol (CAS No 107-21-0)
- Ethylene Oxide (CAS No 75-21-8)
- Formaldehyde (CAS No 50-00-0)
- Methanol (CAS No 67-56-1)
- Methyl Isobutyl Ketone MIBK (CAS No 108-10-1)
- Nickel compounds
- Quartz (14808-60-7)
- Titanium Dioxide (CAS No 13463-67-7)
- Toluene (CAS No 108-88-3)
- Vinyl Acetate (CAS 108-05-4)
- Vinyl Chloride (CAS No 75-01-4)

While these substances may be present in our products, by their very nature, our cable products are infrequently handled. Champlain Cable does not intentionally add these hazardous substances. As such, these constituents are not readily accessible and are therefore exempt from the Prop 65 labeling requirements.

This determination is based on a Consent Judgment Settlement Agreement (San Francisco Superior Court Cases 312962 and 320342) where it was agreed that "Cords and Covered Products", because of their size, weight or function, are infrequently handled. Examples of infrequently handled cords and covered product, in accordance with this Consent Judgment Settlement Agreement, are: building wire, printer cables, riser/plenum cable, speaker wire, telecom data cable, telecom power cable, telephone power and data cords, thermostat cable, utility cable, signal cable, power control/instrumentation/cable, utility wire and cable. Also exempt are cords that are internal components of products not normally accessible to a consumer during ordinary use. Champlain Cable Corporation believes the products it supplies to its customers meets this exemption. Hence, the material is exempt from the aforementioned Prop 65 labeling regulation.

The information provided in this Product Disclosure, and the identification of materials listed as Reportable under Prop 65 is correct to the best of Champlain Cable Corporation's knowledge, information, and belief. This disclosure is designed only as a guide for regulatory compliance to Prop 65's labeling requirements. It is not to be construed as a warranty or quality specification.
